### **Show Hours**

The show is located in Lake Bluff Park on Lake Boulevard in Downtown St. Joseph. Approved set-up time is 7:30 a.m. Please check in with us near the stairway to the right of the cannon on the bluff before setting up. You need to provide your own tables. It is advisable to bring some form of cover for your goods as this is an open air show which takes place rain or shine. Antiques on the Bluff runs from 10 am through 3pm.

### **Booth Information**

Booth spaces are approximately 12' X 12'. You may purchase more than one booth space if you need more room.

### **Parking**

You may unload your goods in front of your space on Lake Boulevard. Per city ordinance It is prohibited to park on any city sidewalk while unloading - you may be ticketed. Once you have unloaded your goods, please move your vehicle to any all-day free parking lot located along Lake Blvd.

### **Tear Down**

Vendors are responsible for removal of all boxes, trash, etc.

### **Liability**

St. Joseph Today accepts no responsibility for loss, damage or theft of merchandise. All vendors need to provide St. Joseph Today with a tax identification number prior to the show if doing two or more shows per year.

### **Cancellations**

Fees are non-refundable due to cancellations or no-shows. NO sub-letting. If you are unable to attend you forfeit your spot and only St. Joseph Today can resell your spot. NO EXCEPTIONS. You must call Kay Wichner at St. Joseph Today if you cancel.

### **Booth Location**

Booth location guarantees are honored with prepaid shows only. Prepaid season contract dealers maintain first right of refusal for guaranteed booth locations. St. Joseph Today reserves the right to sell any booth space that has not been reserved with a payment. You will NOT be assigned a spot nor may you request a spot until you have PAID for your booth for that month. NO EXCEPTIONS!
